

Our facility entrance is located around the Northeast side of the building. Please park in the designated AccessRescue parking area next to the earth berm (large mound).

There is a small AccessRescue sign on the wall by the roll up door and a large sign by the entrance door (behind small guardrail).

**Facility opens at 7:45. Course start time: 8:00 am. Please arrive no later than 7:45.**

Due to Covid-19 accommodations, students are expected to bring their own food and drink. They will also need to provide their own means to maintain perishable food such as bringing their own cooler.

Students will be required to wear a facemask at all times. Student should bring their own facemask that meets CDC specifications.

The NJ Transit does provide extensive bus service to northern New Jersey. This bus option can be difficult to understand if one is not accustomed to the use of major metropolitan bus lines. The nearest bus station utilizes the 752 bus and the drop is near Coppertree Mall at Ramapo Valley Road and Yawpo Avenue. This bus stop is one mile from AccessRescue and is a safe and easy walk (sidewalks) to AccessRescue.

NJ Transit also provides rail service to the north New Jersey area. The closest train stations to our training facility are not within walking distance so utilization of the rail lines would require a cab/uber from the train station to AccessRescue. The nearest train stations are Waldwick and Allendale. Others in the vicinity but further from AccessRescue are Ramsey Route 17 and Mahwah.

## **General Information Pertaining to All AccessRescue Courses:**

All equipment is provided for use during AccessRescue courses at the AccessRescue training facility. Students need only bring suitable footwear and appropriate clothing (stretchy exercise type pants are strongly recommended, jeans are not a good choice). Safety toe footwear is not required. If student has suitable CE/ANSI climbing helmet with chinstrap, they may utilize it during training. Snug fitting gloves are recommended but not required.

### *Required Items for Each Student*

- *Long pants. Shorts can be worn during summer training sessions.*
- *Closed toe shoes. Steel toe boots are not required but can be worn.*
- *Snug fitting gloves optional (no utility or fire gloves).*
- *Eye protection (recommended, not required except during work scenarios)*
- *We provide helmets but student may choose to bring personal suitable climbing helmet with chinstrap.*  
*No fire or construction helmets.*

### *Required Items for SPRAT Certification*

- 1. Government Issued Identification (drivers license, passport etc.).*
- 2. Up-to-date SPRAT logbook with supervisor signatures and cumulative hour totals (Level II's & III's only).*
- 3. Minimum of 18 years of age.*
- 4. Valid email address and mailing address.*

All courses are presented in English unless otherwise stipulated. Please contact us directly for information regarding courses taught in languages other than English. To ensure student safety, AccessRescue reserves the right to turn away student(s) who demonstrate an inability to communicate safely and effectively in English unless prior arrangements for foreign language accommodations have been made. No refunds will be provided in this case.

**AccessRescue Course Refund and Other Policies:**

Courses are refundable minus a \$125.00 administrative fee if request is made 31 days or more prior to start of course.

Courses are refunded minus a \$500.00 fee if request is made 15 days or more prior to the start of course.

Courses are not refundable 14 days or less prior to start of course, nor for the inability of a student to complete a course.

Please contact us to make arrangements for special circumstances that may require variation from our refund policy.

**Absolutely no refunds or substitutions are given for a students inability to complete a course.**

AccessRescue reserves the right to cancel courses for any reason. This typically does not occur. Some potential reasons for course cancellation include but are not limited to low course student registrations, severely inclement weather (disaster), pandemic, or major instructor illness (typically alternate instructor will fill in). Full refunds will only be provided in the event that AccessRescue initiates course cancellation for the above reasons. AccessRescue is not responsible for student expenditures or work loss due to course cancellations. We work very hard to avoid this type of situation.



**Disclaimer:**

AxcessRescue training is physically demanding and requires a strong level of physical fitness. You will be required to climb and descend rope for the entire duration of the course and evaluation session. Prospective attendees that exceed 210 pounds or those that have physical fitness concerns should contact us prior to course registration. Attendees must be able to, at a minimum, squat and stand without assistance 10 times. Leg strength is required to continuously climb and to perform complex rope access maneuvers. All students are encouraged to see their doctor prior to starting any of our courses. Those with cardiac conditions, obesity, surgeries within the past 12 months, or other physical impairments are responsible to see their doctor prior to attempting an AxcessRescue course.

AxcessRescue is not and cannot be responsible for inability to complete a course or successfully pass an evaluation session, or for any condition arising from the exertion required to participate in a course. AxcessRescue reserves the right to not allow any student to continue on with a course in progress if the student displays any level of injury, including bicep pain, or inability to follow directions resulting in unsafe behavior. No refunds or substitutions will be provided in this case.

Course refunds due to inability to complete a course are not available. If a student is unable to complete the course for any reason, no substitutions, refunds, or credits will be allowed and no course time in subsequent courses be provided without additional fees. If a student does not show up for their first scheduled course day, unless there is prior approval from AxcessRescue, they will have forfeited their seat in the course and no refunds will be provided. If a student misses any day or portion of a day of the course for any reason whatsoever, the student will be responsible for the missed time. There is no guarantee that time will permit individualized instruction to get that student caught up. If the student consequently decides to discontinue the course, no course refunds or future course credit will be offered.

Course attendees will be required to sign a waiver of liability prior to starting the course.

***SPRAT Rope Access Course Specific Information:***

The below SPRAT documents (links provided) must be reviewed before the course starts. The SPRAT Safe Practices for Rope Access Work, SPRAT Certifications Requirements for Rope Access Work, and SPRAT Defined Terms (see links provided below) are to be studied ahead of time to prepare for the required written test portion of the evaluation. There will be very minimal review of these documents during the course.

The SPRAT written test will be administered following lunch break the day before the practical skills evaluation unless otherwise stipulated on the 4th day of the course. The last day of each course is reserved for the SPRAT practical skills evaluation unless otherwise stipulated. There will be no additional practice time or course content presentation on this day.

Each student is responsible for passing both the SPRAT written test and the SPRAT practical skills evaluation. AccessRescue cannot guarantee, nor is AccessRescue responsible for student outcomes on these tests. There are no refunds or substitutions provided for test failure. There are fees to re-take any part of the test and/or refresher training.

There is a \$100.00 fee for re-taking a failed written test. There may be limitations as to when the written test can be administered due to SPRAT requirements (see SPRAT.org for details) or test proctor availability.

There is a \$595.00 fee for re-taking a SPRAT skills and written test re-evaluation. This fee does not include any additional training or practice time. There may be limitations as to when a re-evaluation may occur due to SPRAT requirements (see SPRAT.org for details), evaluator availability, space in an evaluation session, or scheduling limitations at AccessRescue.

Each student must bring to the first day of course, a valid government issued form of identification (passport, drivers license, military ID, etc.).

Students SHOULD NOT bring any personal equipment except a work at height helmet with chinstrap. We will provide a sanitized helmet if needed.

SPRAT Certification requires that each student has a valid email and mailing address and this is provided to AccessRescue.

Course records: Course records can only be obtained by the student requesting the information. AccessRescue does not hold or store any sensitive information such as social security numbers or credit card information. All course records are securely stored on a password protected computer system. SPRAT certification records can be requested from the SPRAT office.

For our standard length (4 days + evaluation) rope access courses, we provide 3.8 CEUs (continuing education units) to those that pass the course. The CEUs are provided through our issuance of an AccessRescue certificate. This is not part of the SPRAT certification.
